Europe has been experiencing the worst economic crisis since the 1930's which has a significant negative impact on the quality of life of European citizens. The risk of poverty and social exclusion has increased in most Member State. Children (under 18) remain more at risk of poverty or social exclusion than the overall population with a rate of 27.1% as against 23.5%. Authorities are struggling with austerity measures while often trying at the same time to balance these towards fairer economic and social outcomes. Unfortunately, the negative social consequences of many austerity measures appear to greatly affect some of the most vulnerable groups of the population, giving rise to more severe forms of child poverty and social exclusion across the EU and calling for more systematic social impact assessment of policies. The current crisis is also compromising the ability of the EU to further promote general child well-being. With this conference, the Cyprus Presidency wants to pass the message that even in these difficult times, more investment in children is needed and remains feasible as long as it is recognized as a priority and mainstreamed into all policy areas. The ultimate aim is to generate a dynamic political commitment of the actions ahead.







Europe's social and economic future greatly depends on its capacity to eliminate child poverty and to break the transmission of disadvantage across generations. It is time to acknowledge that tackling and preventing child poverty as well as promoting child well-being is a right on its own. An ageing Europe cannot afford to let itspeople's future potential go wasted.

Fighting against child poverty is a crucial social investment in Europe's long-term future and will make a direct contribution to the Europe 2020 objective of smart, sustainable and inclusive growth.

Against the backdrop of the economic recession and austerity measures, the Conference envisages to arrive at conclusions and recommendations that:

- < Raise the momentum and commitment from key EU and national actors for political measures that are necessary to address child poverty & well-being issues:
- < Raise the momentum and commitment from key EU and national actors to implement the upcoming Commission Recommendation;
- Identify and exchange good practices related to current policy reforms;
- < Make proposals for an EU Roadmap on children's well-being (i.e. what concrete actions can underpin the Recommendation's implementation, including monitoring with the help of indicators).
